OFFICIAL RULES

NO PURCHASE OR PAYMENT OF ANY KIND NECESSARY TO ENTER FOR A CHANCE TO WIN. A PURCHASE OR PAYMENT OF ANY KIND WILL INCREASE YOUR CHANCES OF WINNING. VOID IN ALASKA, FLORIDA, HAWAII, NEW YORK, RHODE ISLAND, PUERTO RICO, U.S. TERRITORIES AND POSSESSIONS AND WHERE PROHIBITED OR RESTRICTED BY LAW.

ELIGIBILITY: The “Win Big with Pennzoil and Joey Logano Sweepstakes” (“**Sweepstakes**”) is open to legal permanent residents of, and physically located within the forty-eight (48) contiguous United States and District of Columbia (excluding FL, NY and RI) who are twenty-one (21) years of age or older at the time entry (the “**entrant**”). Persons in any of the following categories are **NOT** eligible to participate or win a prize: (a) persons who, since **May 24, 2024** were or are employees, shareholders, directors, officers, members, successors, and agents of Speedway GLOBE, LLC (“**Sponsor**”), Pennzoil-Quaker State Company, Kawasaki Motors Corp, U.S.A, NASCAR, LLC, their parent companies, subsidiaries, affiliates, or dealers, or the service agencies of any of the above organizations (collectively, the “**Sweepstakes Entities**”); (b) individuals engaged in the development of, the production or distribution of materials for, or the implementation of this Sweepstakes; or (c) persons in the immediate family of, or persons living in the same household as any person in any of the preceding categories. For the purpose of this Sweepstakes, “immediate family members” are defined as spouse, mother, father, in-laws, grandmother, grandfather, brother, sister, children, and grandchildren. Sweepstakes is void in Alaska, Florida, Hawaii, New York, Rhode Island, Puerto Rico, U.S. territories and possessions and where prohibited or restricted by law. This Sweepstakes is subject to all applicable federal, state, and local laws and regulations.

AGREEMENT TO OFFICIAL RULES: By participating in this Sweepstakes, each entrant is voluntarily providing contact information to Sponsor, which includes entrant’s consent to provide such information to Sponsor and its respective designees, and accepts and agrees to be bound by the terms, conditions and provisions contained in these Official Rules and the decisions of Sponsor, whose decisions will be final in all regards. Sponsor reserves the right to modify or update these Official Rules without notice at any time as may be deemed necessary or required, as determined by Sponsor’s sole discretion.

SWEEPSTAKES PERIOD: The Sweepstakes will start at 9:00:00 am Eastern Time (“**ET**”) on **May 24, 2024** and end at 11:59:59 pm ET on **October 22, 2024** (the “**Sweepstakes Period**”). Sponsor’s computer is the official time keeping device for this Sweepstakes.

TWO (2) WAYS TO ENTER:

(a) **Internet.** Visit <https://www.speedwaymotorsports.com/pennzoil> (the “**Website**”) and follow the online instructions to complete and submit an online entry (“**entry**”).

(b) **QR Code.** Use your smart phone or other web-enabled device with data plan to scan the Sweepstakes quick response (“**QR**”) code featured on signs or promotional materials in the Fan Zone at participating speedways during NASCAR event weekends: Charlotte Motor Speedway (May 24 - 26, 2024 and October 12 & 13, 2024), Sonoma Raceway (June 8 & 9, 2024), New Hampshire Motor Speedway (June 22 & 23, 2024), Nashville Superspeedway (June 28-30, 2024), Atlanta Motor Speedway (September 7 & 8, 2024), Bristol Motor Speedway (September 19-21, 2024) and Las Vegas Motor Speedway (October 19 & 20, 2024). You will be directed to a mobile Web page at <https://www.speedwaymotorsports.com/pennzoil> (also a “**Website**”) where you may complete and submit an entry (also an “**Entry**”). Proof of scanning QR codes does

not constitute proof of completion or submission of an Entry. The participating speedways are subject to change.

To scan a QR code, participants must have a smart phone or other web-enabled device with a camera feature and/or QR scanner application and may incur message or data charges from their wireless service provider for each message sent and received. If you do not have a QR reader already installed on your phone, type 'QR reader' in your mobile device's application store search field to find available QR readers for your smart phone or other web-enabled device. You will receive a response which will contain a link to download a QR reader for your specific device. Check with your wireless service provider for details on these and other applicable charges. Participants are solely responsible for any such wireless charges. Not all wireless carriers participate.

(c) For all Entries. Limit one (1) Entry per person. All entries must be received and recorded during the Sweepstakes Period. Only the methods of entry described above are valid. No other forms of entry are valid. To be valid, each entry must comply with all of these Official Rules. Entrants must complete the online entry form on the Website in its entirety to include full name, address, phone number, and e-mail address. Once submitted, entries become the property of Sponsor and will not be returned. If entering with a mobile phone or other web-enabled device and using your wireless carrier's network, standard data charges from your wireless carrier may apply. Check with your wireless service provider for details on these and any other applicable charges. Entrants are solely responsible for any such wireless charges.

Automated entries are prohibited, and any use of automated devices will cause disqualification. Entrants may not enter with multiple email addresses nor use any other device or artifice to enter multiple times or as multiple entrants. Any entrant who attempts to enter with multiple email addresses under multiple identities or uses any device or artifice to register multiple times will be disqualified and forfeits all prizes won, in Sponsor's sole discretion. Multiple entrants are not permitted to share the same email address. Should multiple users of the same email account enter the Sweepstakes and a dispute thereafter arise regarding the identity of the entrant, the authorized account holder of said email account at the time of entry will be considered an entrant and must comply with these Official Rules. The authorized account subscriber is the natural person who is assigned the email address by the ISP or other organization responsible for assigning email addresses. Potential winner may be required to show proof of being the authorized account subscriber.

DRAWING/ODDS: On or about **November 1, 2024**, one (1) grand prize winner (the "**winner**") will be selected in a random drawing from among all eligible entries received during the Sweepstakes Period. The odds of being selected as the winner is dependent upon the number of eligible entries received during the Sweepstakes Period. The random drawing will be conducted by Sponsor, whose decisions are based upon its sole discretion and interpretation of these Official Rules and are final and binding in all respects.

PRIZE NOTIFICATION/CLAIM: Award and confirmation of the winner is contingent upon potential winner's qualification and compliance with these Official Rules. Potential winner will be notified by email and telephone (the "**Notification**"). Before being declared a winner, the potential winner must respond to the Notification within the time frame indicated by providing a completed Affidavit of Eligibility/Liability/Publicity Release Form and an IRS Form (the "**Required Documents**"). Sponsor reserves the right, in its sole discretion, to disqualify and randomly select an alternative potential winner if: (a) the potential winner does not respond within the Notification timeframe; (b) the Notification is returned as undeliverable; (c) the potential winner fails to provide Sponsor with satisfactory proof of age, identity, residency or eligibility or provide the Required Documents; (d) the potential winner declines acceptance of the Prize; and (e) if in Sponsor's determination, the potential winner has not complied with these Official Rules.

In the event of noncompliance, to be determined at the sole discretion of Sponsor, Prize will be forfeited and will be randomly awarded to an alternate winner (time permitting).

In the event of noncompliance within any stated time period, the Prize will be forfeited, and an alternate potential Prize winner will be randomly selected (time permitting). Any alternate potential Prize winner selected will also be required to adhere to the time periods described herein. Any prize notification or prize returned to the Sponsor as undeliverable will result in disqualification and the awarding of that prize to an alternate potential winner (time permitting).

GRAND PRIZE: One (1) Prize will be awarded. Prize winner will receive a Kawasaki® Side-by-Side Vehicle having an approximate retail value (“**ARV**”) of up to \$20,899 (color, options and accessories to be determined at the sole discretion of the Sponsor) (“**Prize Vehicle**”) and a VIP Race Weekend Experience for two (2) to the 2025 Pennzoil 400 race weekend at Las Vegas Motor Speedway (“**Prize Trip**”) (collectively, the “**Prize**”) consisting of:

- Air travel for winner and one (1) guest, round-trip, coach, to Las Vegas, Nevada in 2025
- One (1) double-occupancy hotel room accommodations for three (3) nights for winner and one (1) guest in Las Vegas, Nevada
- Two (2) Black Jack Club weekend tickets, for winner and one (1) guest, to attend the 2025 Pennzoil 400 race weekend at Las Vegas Motor Speedway (“**Event**”)
- One (1) VIP Parking Pass for the Event
- Two (2) VIP Passes for the Event
- At-Track Meet and Greet with Joey Logano
- Sit on the No. 22 Penske Racing Team pit box for a portion of the Pennzoil 400

Total ARV of the Prize is \$26,500.00.

PRIZE CONDITIONS: All expenses and other costs not expressly stated in the Prize description are the sole responsibility of the Prize winner. Restrictions, conditions and limitations may apply. The Prize cannot be substituted, assigned, transferred, or redeemed for cash; however, Sponsor reserves the right to make an equivalent Prize substitution at its sole discretion. No Prize transfer, assignment, or substitution by the Prize winner is permitted. No more than the stated number of Prizes will be awarded. In the event that technical,

programming or any other errors or reasons cause more than stated number of Prizes as set forth in these Official Rules to be available and/or claimed, Sponsor reserves the right to award only the stated number of Prizes in accordance with the winner selection method described above from among all eligible claimants making purportedly valid claims.

The Prize winner is responsible for reporting and paying all taxes associated with a Prize winner's receipt of the Prize. Sponsor may withhold and/or report taxes as required by the applicable laws of Sponsor's and Prize winner's jurisdictions. All federal, state, and local tax liabilities, as well as any other costs and expenses not specified herein as being awarded are the sole responsibility of the Prize winner. The Prize is provided "as is" and the Prize winner assumes all risks associated with its use. Sponsor hereby disclaim any and all warranties, whether express or implied, associated with the Prize.

Prize winner will not receive the difference between the actual retail value and approximate retail value. If any Prize winner cannot accept Prize as stated, then the Prize will be forfeited and an alternate winner will be selected as set forth above.

PRIZE VEHICLE CONDITIONS: Prize winner will be solely responsible for any applicable registration, license, title and insurance fees, all taxes (federal, state, local, sales and/or income) and any expenses not listed herein related to the acceptance and use of the Prize Vehicle. Prize Vehicle will have a standard factory warranty. Make, model, color, options and accessories to be determined at the sole discretion of the Sponsor. SPONSOR MAKES NO OTHER WARRANTIES, EXPRESS OR IMPLIED, AS TO THE QUALITY OF CONDITION OF THE VEHICLE AND EXPRESSLY DISCLAIMS ANY WARRANTY OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE. Prize winner is required to comply with any and all applicable federal, state and local laws, rules and regulations including, but not limited to licensing and insurance requirements. Any difference between stated MSRP and actual value of the Prize Vehicle will not be awarded.

Prize winner will take delivery of the Prize Vehicle at a Kawasaki dealer as designated by Sponsor within 90 days of notification that Prize Vehicle is available. Winner must have or obtain and provide proof of liability insurance prior to the time of delivery of the Prize Vehicle. All travel-related expenses to the Kawasaki dealer are the responsibility of the Prize winner. In the event of noncompliance, the Prize Vehicle will be forfeited.

The Prize winner shall bear all risk of loss or damage to the Prize Vehicle after it has been delivered. The depiction of the Prize Vehicle in any advertising or promotional materials or physical display may not reflect the actual vehicle provided to the Prize winner.

TRIP PRIZE CONDITIONS: Guest must be twenty-one (21) years of age or older as of the end date of the Sweepstakes Period. Trip Prize includes (i) roundtrip coach airfare for two (2) persons from the airport nearest the Prize winner's residence to Las Vegas, Nevada, (ii) standard hotel accommodations (one (1) double-occupancy hotel room accommodations for three (3) nights/four (4) days) in a Las Vegas area hotel. Travel restrictions, conditions and limitations may apply. ARV of Trip Prize may vary depending on point of departure, travel dates and fare/rate fluctuations. Each person who participates in the Prize that is not deemed to be a guest must pay all their own expenses.

Prize winner and its guest must be able to travel on dates to be determined by Sponsor. Exact dates of travel to be determined at Sponsor's discretion. If the Prize winner resides within a 60-mile radius of Las Vegas, Nevada (a "**local resident**"), in lieu of the round-trip air transportation portion of the Prize, ground transportation or a gift card may be substituted. No

compensation will be awarded in lieu of the difference in the ARV for the that portion of the prize for a local resident and the ARV for the portion of the prize who is not a local resident.

Sponsor will determine which airport is closest to the winner's home. Winner and its guest must travel together. Travel subject to availability and blackout dates. Winner and its guest are responsible for obtaining all necessary travel documents. Travel arrangements must be made through Sponsor's agent and on an airline carrier of Sponsor's choice. If required, winner must be available to travel on dates specified by Sponsor or risk forfeiting prize. Certain travel restrictions may apply. If winner elects to travel or participate in the prize travel with fewer than one (1) guest, no additional compensation will be awarded. If winner elects to travel or participate in prize travel with more than one (1) guest, such additional persons shall be responsible for any and all costs associated with such travel and Sponsor shall not be responsible for coordinating the travel or accommodations of such additional person(s). No refund or compensation will be made in the event of the cancellation or delay of any flight except at Sponsor's discretion. Travel is subject to the terms and conditions set forth in these Official Rules, and those set forth by Sponsor's airline carrier of choice as detailed in the passenger ticket contract. The passenger contracts in use by the airlines or other transportation companies shall constitute the sole contracts with respect to the Prize winner's and winner's guest's transportation and such contracts shall be solely between the Prize winner, winner's guest and such transportation companies. Lost, stolen or damaged airline tickets will not be replaced or exchanged. With the exception of stopovers approved in advance at Sponsor's sole discretion, no stopovers are permitted on tickets issued as part of the Prize. If a stopover occurs, the prize travel will terminate and winner and winner's guest will be responsible for the full fare which will be charged from the stopover point for the remaining trip segment(s), including the return. Tickets and Passes. The Event is rain-or-shine. Actual seat location will be determined by Sponsor in its sole discretion. Event tickets are subject to Terms and Conditions stated thereon and tickets are non-transferable and the resale of tickets are prohibited. Venue restrictions may also apply. Ticket delivery method is at sole discretion of the Sponsor. Date and location of the event is subject to change and not the responsibility of Sponsor. If the Event is canceled for any reason, Sponsor's only obligation is to award, or not award, the other elements of the Trip Prize, in its sole discretion.

Meet and Greet and Pit Box Experience. Any VIP access component or meet and greet component of the Trip Prize is subject to availability and will be supervised by Sponsor and prize provider. VIP access component and meet and greet component may be modified, curtailed or even cancelled altogether at the sole discretion of Sponsor or prize provider due to scheduling and/or other circumstances beyond their control. Event tickets and passes awarded as prizes may not be resold or offered for resale. Any such resale may result in disqualification and Prize forfeiture, and may invalidate the license granted by the event tickets. Sponsor will not be responsible for weather conditions, Acts of God, acts of terrorism, civil disturbances, work stoppage or any other natural disaster outside their control that may cause the cancellation or postponement of any event.

Behavior. In the event winner and/or its guest engages in behavior during travel or any events associated with the Prize that (as determined by Sponsor in its sole and absolute discretion) is obnoxious, inappropriate, or threatening, illegal, or that is intended to annoy, abuse, threaten or harass any other person, or that in any way disparages or adversely affects the reputation, image, and/or customer goodwill of Sponsor or the Sweepstakes Entities or any of Sponsor or the Sweepstakes Entities, services, products, trademarks, service marks, or logos, Sponsor reserves the right to terminate the travel early, and send winner and/or guest home with no further obligations or compensation whatsoever to winner and/or guest (which may, in Sponsor's discretion, result in such winner's disqualification from the Sweepstakes and forfeiture of any (and/or all) prize(s)). By participating in the Sweepstakes, Entrants grant Sponsor permission to correspond with them via email regarding the Sweepstakes, to share Entrant's email address and any other personally identifiable information with the corresponding Sweepstakes Entities or third parties for the purpose of Sweepstakes administration, communication, fulfillment, or for any other purposes permitted by these Official Rules or privacy policy. If you are verified as a prize winner, your first name, last initial, city and state will be included in a publicly available winner's list. Sponsor will not sell, rent, transfer or otherwise disclose Entrant's personally identifiable information to any third party other than as permitted by these Official Rules or privacy policy.
